Stability: Stable for 3 months at 4°C, 20°C, 40°C, 1 month at 45°C

PROCEDURE:

1. Mix the components of phase A while stirring and heat up to 60°C.
2. Mix the components of phase B while stirring and heat up to 60°C.
3. Add phase B to phase A and homogenize for 3 –5 minutes.
4. Cool down to 35°C and add phase C.
