PREPARATION:

Mix HYDRIOL® CLA Pure, EasyTens® S2 Pure, Plantacare® 818 UP, Sodium Citrate and PuraBeet® together, heat up to 60°C and stir until the liquid mixture is homogeneous.

Add MG-60, Annato Oil, Babassu Oil, BioDTox®, QUEMINA 21.257, POTATO-JEL NATURAL and MALTODEXTRIN 20.235 while stirring.

Add Hostapon® SCI-85 P while stirring.

Heat up to approx. 80°C for 15 – 20 minutes and add some dyestuff if desired.

Add the perfume during the cooling process as late as possible.
