PROCEDURE

- 1. Mix the ingredients of phase A with appropriate stirring equipment (e.g. propeller stirrer) until homogeneous.
- 2. Add phase B while stirring thoroughly until binder is spread homogeneously.

3. Press powders into godets with suitable powder press equipment (e.g. Kemwall, 80-90 bar for godet size 23x20 mm)
