PROCEDURE

1. Charge water to main and begin propeller mixing. Begin heating to 75 °C. Add the ingredients of phase A.
2. In a side container combine the ingredients of phase B. Begin mixing and heating to 75 °C. Add phase B to main and immediately add Simugel (phase C) and continue mixing for 15 – 20 minutes.
3. Begin force cool. Switch to sweep mixing. At 50 °C begin adding the ingredients of phase D on at a time as listed.
