PROCEDURE

1. Mix phase A until it is homogeneous and heat to 75°C.
2. Mix Optigel WX-PC and water under high shear and adjust to pH 6.5 with lactic acid.
3. Add Glycerin and heat to 75°C.
4. Add phase B to phase A under high shear.
5. Cool down and add phase C step by step to phase AB.
6. Pour into an appropriate container.
