#### PROCEDURE

- 1. Put the ethanol in first and whilst stirring enter the components ADVANTAGE LC-E, X-TEND 226, Pink Pearl (BELL) one after the other whilst maintaining constant.
- 2. Stirring. Subsequently Tixogel VSP-1438 is added potion wise under stirring and homogenized for approx. 10 minutes at approx. 11000 rpm.
- 3. After a beige homogenous mix is obtained the D.S.A. 7 is added portion wise whilst stirring for 15 minutes
